REGISTRATION NO.CH01-G1-0222.


State Legal Services Authority, U.T., Chandigarh intends to dispose off one condemned staff car Innova bearing registration No.CH01-G1-0222 through the public notice on 29.10.2020 at 11:00 A.M in the premises of State Legal Services Authority, U.T., Chandigarh as per the following terms and conditions:-

DESCRIPTION OF VEHICLE

1. The vehicle will be sold on "AS IS WHERE IS BASIS". The auction process will be conducted by auction committee of this office. Taxes and duties that may be levied by Government will be extra as applicable.
2. The bidder may inspect the said vehicle on 20.10.2020 from 10:00 A.M to 12:00 P.M and may contact the auction committee of this office.
3. Every intending bidder will have to register himself by depositing 10% of the reserved price in cash as earnest money to be deposited at least 30 minutes before the scheduled time of auction.
4. The successful bidder shall have to deposit 25% payment against their bid after adjusting the security/earnest money deposited on the spot. If highest bidder does not accept the offer of sale of vehicle for any reason whatsoever, and withdraws from the bidding, the Earnest Money Deposit (referred as EMD hereinafter) deposited by such bidder will be forfeited. Then the second highest bid amount may be considered for sale, if accepted by the Auction Committee and accordingly the second highest bid amount will be considered as the highest bid amount or the aforesaid vehicle may once again be taken up for re-auction on the same day as per decision of the Auction Committee.
5. The EMD of unsuccessful bidders shall be returned on the spot.
6. The successful bidder shall be handed over with the delivery of the vehicle within a period of 10 days from the date of auction.
7. The successful bidder shall have to deposit the remaining quoted amount within a period of 10 days for taking delivery of vehicle. In case of failure to take the delivery of the vehicle, he will forfeit his right over the vehicle and his bid shall be deemed to be cancelled and earnest money deposited by the bidder shall be forfeited.
8. The person authorized by bidder will be allowed to take the delivery. The bidders are required to produce any of these documents viz. Aadhar Card/Voter Identity Card/Passport/PAN Card as documentary evidence for proof of their identity and address.

9. This office will not owe any responsibility for transfer of vehicle and for any other liability for using this vehicle for commercial or any other purpose after sale.
10. Once the release order is issued or handing over of vehicle is completed, this office will not be responsible either for safe custody or for any loss or damage to the subject vehicle.
11. The staff car shall be sold to the highest bidder.
12. The highest bid once accepted is not transferable to anyone else.
13. The above said car, once handed over to the successful bidder, shall not be taken back by the o/o State Legal Services Authority, U.T., Chandigarh.
14. The purchaser will be responsible for all future legal disputes whatsoever, pertaining to the vehicle after taking delivery.
15. **The State Legal Services Authority, U.T., Chandigarh reserves the right to cancel the auction process at any stage without assigning any reason.**
16. Incomplete and unsigned form(s) is/are liable to be rejected.
17. The EMD deposited shall not attract any interest.
18. The Auction Notice is attached with this Notice as Annexure-I.
19. The decision of the Auction Committee for all the purposes shall be final and binding.
20. SLSA, U.T., Chandigarh shall continue to observe social distancing norms as prescribed by the Government of India. Wearing face masks is compulsory so everyone who intends to participate in the auction process is required to wear face mask during the auction and subject to screening. The State Legal Services Authority U.T., Chandigarh will also follow the guidelines and orders issued by the Government of India and Chandigarh Administration relating to COVID-19 from time to time.
