**FOR THE ENGAGEMENT OF TWO MEMBERS FOR PERMANENT & CONTINUOUS
LOK ADALAT, U.T., CHANDIGARH, ADR CENTRE, DISTRICT COURTS COMPLEX,
SECTOR-43, CHANDIGARH**

A Permanent and Continuous Lok Adalat was set up in Chandigarh in the year 1998 and now it is functioning from ADR Centre, District Courts Complex, Sector-43, Chandigarh. As per Section 19(5) of the Legal Services Authorities Act, 1987, the Permanent and Continuous Lok Adalat, U.T., Chandigarh has the jurisdiction to determine and to arrive at a compromise or settlement between the parties to a dispute in respect of –

- (i) any case pending before; or
- (ii) any matter which is falling within the jurisdiction of, and is not brought before, any Court for which the Lok Adalat is organized:

Provided that the Lok Adalat shall have no jurisdiction in respect of any case or matter relating to an offence not compoundable under any law.

Therefore, the Permanent and Continuous Lok Adalat, U.T., Chandigarh has the jurisdiction to deal with pre-litigative and pending Court matters relating to bank recovery cases; criminal compoundable offence cases; labour dispute cases; land acquisition cases; MACT cases; matrimonial disputes cases, NI Act cases, etc.

The Permanent & Continuous Lok Adalat is presided by the Secretary, District Legal Services Authority, U.T., Chandigarh and there are two other Members in the same. As per Regulation 18 of State Legal Services Authority U.T., Chandigarh (Transaction of Business and Other Provisions), Regulations, 1998, the following persons are eligible to be engaged as Members of Permanent & Continuous Lok Adalat, U.T., Chandigarh:

- I. A serving or retired Judicial Officer
- II. A Member of the Legal profession having at least 10 years of practice.
- III. A (local) Social Worker of repute who is engaged in upliftment of the weaker sections of the society.

Applications complete in all respect as per prescribed format along with attested copies of birth certificate, educational qualification, experience certificate, bar enrolment certificate, I.D. proof, etc. duly attested by the Gazetted Officer are invited from eligible advocates having at least 10 years of experience/practice in legal profession; serving or retired Judicial Officers; Social Worker (locally based) of repute who is engaged in upliftment of the weaker sections of the society **for two posts of Member**, Permanent & Continuous Lok Adalat, U.T., Chandigarh for **a period of one year**. The applications should submit in this Authority in person or by post only. The honorarium of the newly engaged Members of Permanent & Continuous Lok Adalat will be ₹ 2,000/- per day. The last date of receipt of application in this office is **09.09.2022 till 05:00 PM**.
