In continuation of earlier advertisement published on 05.06.2016, the State Legal Services Authority, Union Territory, Chandigarh invites applications from eligible candidates for filling up of one post of Member for the Permanent Lok Adalat (Public Utility Services), Union Territory, Chandigarh alongwith latest passport size photograph, biodata mentioning therein qualification and relevant experience. As per amended Rule 4(2) of the Permanent Lok Adalat (Other Terms and Conditions of Appointment of Chairman and Other Persons) Amendment Rules, 2016, the Member shall hold office for a term of 5 years or till the age of sixty five years, whichever is earlier. Persons who have already applied in response to earlier advertisement dated 05.06.2016 need not apply again as the applications of all the eligible candidates shall be considered. The last date of receipt of application is 12 August 2016.

**ELIGIBILITY CRITERION FOR THE POST OF MEMBER, PERMANENT LOK ADALAT (PUBLIC UTILITY SERVICES) UNDER THE LEGAL SERVICES AUTHORITIES (AMENDMENT) ACT 2002**

Section 22B (1) Notwithstanding anything contained in section 19, the Central Authority or, as the case may be, every State Authority shall, by notification, establish Permanent Lok Adalats at such places and for exercising such jurisdiction in respect of one or more public utility services and for such areas as may be specified in the notification.

(2) Every Permanent Lok Adalat established for an area notified under sub-section (1) shall consist of –

- (a) a person who, is or has been, a District Judge or Additional District Judge or has held Judicial Office higher in rank than that of a District Judge, shall be the Chairman of the Permanent Lok Adalat; and
- (b) two other persons having adequate experience in public utility service to be nominated by the Central Government or, as the case may be, the State Government on the recommendation of the Central Authority or, as the case may be, the State Authority, appointed by the Central Authority or, as the case may be, the State Authority, establishing such Permanent Lok Adalat and the other terms and conditions of the appointment of the Chairman and other persons referred to in clause (b) shall be such as may be prescribed by the Central Government.

सं.सं.नि. 618(अ)—केन्द्रीय सरकार, विधिक सेवा प्राधिकरण अधिनियम, 1987 (1987 का 39) की धारा 27 द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए भारत के मुख्य न्यायाधीश के परामर्श से स्वायी लोक अदालत (अध्यक्ष और अन्य व्यक्तियों की नियुक्ति के अन्य नियंत्रण और शर्तों) नियम, 2003 का और संशोधन करने के लिए निम्नलिखित नियम बनाती है, अर्थात् :-

- (1) इन नियमों का संक्षिप्त नाम स्वायी लोक अदालत (अध्यक्ष और अन्य व्यक्तियों की नियुक्ति के अन्य नियंत्रण और शर्तों) संशोधन नियम, 2016 है।  
(2) ये राजपत्र में प्रकाशन की तारीख को प्रवृत्त होंगे।
- स्वायी लोक अदालत (अध्यक्ष और अन्य व्यक्तियों की नियुक्ति के अन्य नियंत्रण और शर्तों) नियम, 2003, (जिसे इसे इसके पश्चात् मूल नियम कहा गया है) के नियम 3 में,
  - उपनियम (3) में "चार सौ रुपए" शब्दों के स्थान पर, "एक हजार पाँच सौ रुपए" शब्द रखे जाएँगे;
  - उपनियम (3) में "तीन हजार रुपए" शब्दों के स्थान पर, "पाँच हजार रुपए" शब्द रखे जाएँगे।
- मूल नियम के नियम 4 के उपनियम (2) के स्थान पर, निम्नलिखित उपनियम रखा जाएगा, अर्थात् :-  
(2) अध्यक्ष और अन्य व्यक्ति पाँच वर्ष की अवधि के लिए या दस वर्ष की उम्र तक इनमें से जो पूर्वोक्त के लिए पद धारण करेंगे।

NOTIFICATION

New Delhi, the 22nd June, 2016

G.S.R. 418(E).—In exercise of the powers conferred by Section 27 of the Legal Services Authorities Act, 1987 (79 of 1987), the Central Government in consultation with the Chief Justice of India, hereby hereby amends the following rules further to amend the Permanent Lok Adalat (Other Terms and Conditions of Appointment of Chairman and Other Persons) Rules, 2003, namely:—

1. (1) These rules may be called the Permanent Lok Adalat (Other Terms and Conditions of Appointment of Chairman and Other Persons) Amendment Rules, 2016.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. In the Permanent Lok Adalat (Other Terms & Conditions of Appointment of Chairman and Other Persons) Rules, 2003, (hereinafter referred to as the principal rules), in rule 3.—

(i) In sub-rule (3), for the words "rupees four hundred", the words "one thousand and five hundred rupees" shall be substituted.

(ii) In sub-rule (5), for the words "rupees three thousand", the words "Five thousand rupees" shall be substituted.

3. In the principal rules, in rule 4, for sub-rule (2), the following sub-rule shall be substituted, namely:—

"(2) The Chairman and other persons shall hold office for a term of five years or till the age of sixty five years, whichever is earlier".
