Important Instructions for Candidate for the Computer Proficiency Test for the Post of Steno-Typist to be held on 09.05.2018.

1. Candidate shall reach in the office of State Legal Services Authority, Additional Deluxe Building, Sector-9, Chandigarh at 9:00 AM sharp. Anyone coming after the reporting time will not be allowed to take the test.
2. You are not allowed to leave the examination hall till the paper is over.
3. Any Candidate found in possession of Calculators communication aids (Mobile Phone etc.) or any other electronic device during the examination shall be disqualified.
4. Candidate shall ensure that he/she fulfills the eligibility conditions specified in the advertisement before appearing in the test. His/her appearance in the test is purely provisional. Mere appearance and qualifying the test shall not confer any right for appointment to the post without fulfilling the minimum eligibility conditions.
5. The candidate shall produce the letter issued to him/her alongwith original photo, identity proof at the examination centre, which may be Aadhar Card, Driving License, Voter ID, Passport or PAN Card.
6. No candidate will be allowed to appear in the test without letter and original photo identity proof.
7. Candidate has to affix his/her photograph on letter which he/she will paste and self attest it. Otherwise the candidate will not be allowed to sit in test.
8. The letter shall be handed over to the invigilator in the examination hall after the test.
9. No. TA/DA will be paid for appearing in the test.
10. In case the candidate did not receive the letter he/she can get the same from this office after showing his/her identity proof.
